16.Multidisciplinary / interdisciplinary

The University understands that a multidisciplinary and holistic approach to education is instrumental in developing integrated individuals. IN NEP-2020, it is

a ground-breaking move as it helps the students to learn sciences, technologies, and mathematics with liberal arts, humanities, languages, social sciences, professional skills, vocational skills, ethics, morality, human values, and so on at the same time. This integrated approach can make students more marketable in today's workforce. Keeping in view this mandate of NEP-2020 and moving from a single stream towards a multidisciplinary/ interdisciplinary university structure, the University constituted 8 special committees to fulfill this objective. Further, the University is also in the process of identifying its thrust areas of integrating modern subjects with traditional ones viz. Architectural engineering/ town planning, civil engineering/ with Vaastu and Shilpa Shastra, Indian psychology and yoga, law and jurisprudence with dharmashastra, etc. The University is also in process of encouraging original and deep scholarly research in the Indian Knowledge Systems to rejuvenate IKS research in the campus.

#### 17.Academic bank of credits (ABC):

As per the NEP-2020 framework, the Academic Bank of Credit (ABC) will allow the University to maintain a digital repository of credits earned by the students. Under ABC, credits awarded to a student for one program from an institution will be transferred/redeemed by another institution upon the student's consent. Here, credit transfer will be the key to successful study mobility. For the implementation of ABC through the National Academic Depository (NAD), a Committee was constituted by the Academic Council for implementation of the same in the University.

In University, the Academic Bank of Credits will be established on the lines of the National Academic Depository (NAD) where the students' academic data are held and academic awards will be stored (i.e. storehouse of academic awards). However, the final outcomes of credit redemption and issuance of certificates, as well as the compilation of award records, will be administered by the University via the NAD Platform.

#### 18.Skill development:

The University runs a number of courses through which students learns a number of skills that are required to enhance their employability by providing the students the right skillsets. Through its courses, learners acquire a number of skills viz. soft skills, communication skills, information and communication technology, training on karmakand and Vedic recitation, spoken Sanskrit, yoga, and meditation, guidance for competitive examination, teaching skills, etc. The University also focuses on the revival of the language of the Vedas i.e Sanskrit, Indianness associated with Sanskrit, and the language-based education system. The university overall focuses on academic development, skill development, and physical-mental development of the students. Students are made to learn Vedas, Priesthood, Grammar, Astrology, Vastu Shastra, etc. Many pooja rituals practiced around the world are also being studied along-with practical experience. The Education department provides synchronization with the aspirations and ideas that are being disseminated as a result of globalization, modernization, and technology-supported educational programs. It offers a wide range of programs and creates competencies in Sanskrit language pedagogy. For developing skills in ICT, the University runs self-financing Certificate and Diploma courses in computer programming and office automation. Shri Lal Bahadur Shastri National Sanskrit University apart from its regular courses runs various self-financing programmes in Jyotish, Vastushastra, Yoga and Meditation, Paurohitya Prashshikshan, Sanskrit Prashikshan, Web-designing, medical astrology, etc. which imparts various employability skills in the learners required in day to day life.

19. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The IKS courses are intended to provide the students with a foundational guide to the history, culture, and philosophy of India and introduce them to the main themes and debates relating to that history. It is also intended to equip them with certain basic skills including individual and group work, project research, seminar presentation, and essay writing. Indian Knowledge system focus on the Idea of India, Indian Philosophy, Society, Arts, Language & Literature, Science & Technology, and History.

Shri Lal Bahadur Shastri National Sanskrit University being a traditional Sanskrit university has taken a step in integrating modern subjects with traditional Indian ones viz. mathematics and astronomy, architectural engineering with Vastu and Shilpa shastra, Indian psychology and yoga, etc,. For this, the University has already initiated the process for the establishment of IKS centre in the University and Research proposals for the faculty members of the university.

#### 20. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

Outcome-Based Education (OBE) can be termed as student-centric teaching and learning methodology in which the course delivery and assessment are planned to achieve stated objectives and outcomes. It focuses on measuring student performance i.e. outcomes at different levels and includes various aspects viz. Course, Course Outcomes, Program Outcomes (PO), Program Specific outcomes (PSO), Learning Outcomes, etc. Further, Outcome-based education is also assigned a number of graduate attributes each of which has its own distinct importance and meaning.

The University is of the view that course learning focuses on measuring students' performance through outcomes which include knowledge, skills, and attitudes. Accordingly, the University has focussed on the development of an outcomes-based syllabus. The Program Outcomes (POs), Program Specific Outcomes (PSOs), course objectives, etc. of all Programs and courses will be prepared in alignment with the University vision, mission, and learning requirements of the students.

The course outcomes shall be further mapped with the Program outcomes and aligned with Bloom's taxonomy learning levels. Similarly, Course outcomes shall further be mapped with the Course Delivery methods. For this, University is in process of finalization of course outcomes prepared after a series of discussions among all the teachers of various departments of the University.

#### 21. Distance education/online education:

Education through Open and Distance Learning modes involves providing flexible learning opportunities by overcoming the separation of teacher and learner using a variety of media, including print, electronic, online, and occasional interactive face-to-face meetings with the learners or Learner Support Services to deliver teaching-learning experiences, including practical or work experiences. In today's scenario, Open and Distance Learning has a number of advantages viz. Course Flexibility, Innovative curriculum, accessibility of time & place, efficiency, affordability, etc.

Keeping in view the benefits and importance of Distance and Online Education, facilitating accessible and affordable quality education to students and learners in the field of Sanskrit and imparting Sanskrit, Traditional and Shastriac education even to students and learners residing in the remote location of the country, the IQAC of Shri Lal Bahadur Shastri National Sanskrit University has initiated necessary measures to conduct the University courses through Open and Distance Learning and Online Mode.

The development of every course in every programme of study offered by Shri Lal Bahadur National Sanskrit University (SLBSNSU) takes into consideration local, national, and international needs for development. Every department of study that provides a programme has a Board of Studies (BoS) composed of faculty and outside topic experts who, after discussion, approve the curriculum of any course. Every programme presents programme outcomes, programme-specific outcomes, and carries course outcomes of each course. Additionally, each course/subject of any given programme carries a course objective that unfolds the learning outcome for that course.

In the instance of SLBSNSU, the local necessities can be considered on two different levels: 1) geographical, such as city or town surroundings, and 2) linguistic. Due to the fact that SLBSNSU is a Sanskrit university and offers all of its programmes in Sanskrit, with the exception of language programmes, the first work to be addressed was to develop the course/subject material of all the courses in Sanskrit, which has relevance to the national and global developmental needs. As a result, SLBSNSU has offered curricula that are on par with those of any national or international university and has employed both approaches to satisfy this common necessity.

Shri Lal Bahadur Shastri National Sanskrit University give emphasis on improving the performance of slow learners through a number of imrovement techniques. For students who lags in understanding the concepts,remedial programmes are conducted outside regular classes. The Career Counseling Cell has been mandated for skill development. The Short-term Spoken English course, Sanskrit Sambhashan, Palaeography, and Computer Literacy programs are organized by the Cell. The Career Counselling Cell is working for performance enhancement for slow learners. The students are encouraged to participate in different programmes organized by other universities/institutions.				

The efforts taken by the faculty towards the slow learners has resulted in students' understanding in their chosen domain and their performance improvement.Students having other skills and strengths are also identified and

encouraged which helps build self-confidence resulting in improvement in academic performance also. Students with socio-economic backgrounds are given special attention through necessary emotional and professional counselling whenever required. The University ensures that a slow learner clears his courses within the time frame and also provided extra attention to build additional skills which makes them employable.

Advanced learners are identified through their performance in examinations, interaction in class room and laboratory, their fundamental knowledge, concept understanding and articulation abilities etc. The University promotes independent learning that contributes to their academic and personal growth. Those who have direct instructional and supportive contact with the students and those who lead assessment initiatives are responsible for motivating and involving the rest of the campus community.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

The University practices a teaching methodology which focuses on imparting sanskrit and shastric education through a student centric approach. The University has created a learning environment that nurtures exploration and critical thinking. The teacher facilitates learning by allowing each individual student to comprehend at their personal level.by ensuring their involvement in class activities so that they can absorb and grasp information at their own pace. The University imparts education through Experimental Learning, Participative Learning and Collaborative learning. This methodology helps to transform students from being relegated to the role of passive recipients to active and involved stake holders, apart from boosting their confidence and encouraging independence.

The members of the faculties are providing hand-outs to the students and also assignments as per the requirement of the Choice Based Credit System. They make seminar presentations. Under the supervision of the Dean of Students welfare, group discussions, guizzes and extra-curricular activities are organized with a view to take care of the holistic development of the students. Teachers make classes as interactive as possible and encourage innovative thought and novel interpretations. Audio- Visual methodology, Language Lab, Internships, Field Work and Projects are some of the means utilize by the University to provide experiential and participative learning.

The Faculty of Shri Lal Bahadur Shastri National Sanskrit University use online education resources, e-learning platforms like MOOCS, SWAYAM to effectively deliver teaching and provide enhanced learning experience to the students. The Education Departments of the University have laboratories relevant to their subjects. These laboratories fortify the knowledge acquired in tradtional classes. The e-learning portal are integrated with teacher's explanation and students are encouraged to learn and practice through interactive activity.

The University has established computer labs for the students of Shastraic tradition and Education (B.Ed. and M. Ed). Apart from computerisation of all the sections/ departments, the Deans of the Faculties/HODs have also been provided computer with ICT facilities. Wi-Fi has also been provided in library, hostel, guest house and common rooms of the students. Apart from this,online learning environments like Google Suiteare designed to train students in open problem-solving activity.Media lab facility is used to create video lectures and upload in appropriate platforms for students to use as extra learning resources.

Shri Lal Bahadur Shastri National Sanskrit University has a long tradition of research in areas of Sanskrit, Shastras, Sanskrit Literature and heritage, auxiliary components of Sanskrit viz. Jyotish and Vastu Shastra etc. A significant fraction of students of University are fact, research scholars pursuing M.Phil, Ph.D., and other research-based programs.

The core function of the Research Department is to integrate the academic and research activities under one framework, provide faculty opportunities for academic collaborations, and provide students opportunities to work on research-based problems in Sanskrit, Shastras, and Fields of Sanskrit-based knowledge. The University is also committed to high-level research in other languages and literature of Asia which have a bearing on Sanskrit literature. Emphasis has been on Vedic Sanskrit i.e. classical Sanskrit and studies in contemporary literature in Sanskrit. Various new components have to be taken while providing specialized means for training of Sanskrit teachers and research in pedagogical aspects of Sanskrit education, Studies on Human Rights, Environmental management, and also on Women as envisaged in our Sanskrit literature, particularly Veda, Puranas, and Dharma Shastras.

The research promotion policy of the University has been framed to focus on its vision, mission, and core values, and has been outlined in the policy document displayed on University's website. The University's research policies and regulations are in updated in accordance with the NEP-2020 guidelines.

In the University, there is an independent Publication unit that collects, preserves, and publishes historical publications authored by prominent scholars. It also brings out a research journal which carries its own distinction. In addition to this, the University is proud of its Manuscript collection which is an asset with all its rare valuable manuscripts. There are number of manuscripts on different subjects. These manuscripts are related to different branches of Sanskrit literature-Vedas, Upnishads, Puranas, Astrology, Vyakarana, Vedanta, Sankhya Yoga, Nyaya, Karma-Kanda, Dharma Shastra, Sahitya, Music and Ayurveda. The University also publishes research journals "Shodhprabha" at the institutional level whereas its various departments like Jyotish, Vastushastra etc. publish journals in their area of research.

### INFRASTRUCTURE AND LEARNING RESOURCES

### 4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The University continues to excel in its commitment to teaching, learning and research in Sanskrit. With around 108 regular faculty and approx 1100 regular students from across India, the diversity is particularly encouraging with proportionate male-female ratio. The four Academic Buildings in the University are:-Shaikshanik Sadan, Saraswat Sadhana Sadan, Vrihaspati Bhawan, Swarna Jayanti Sadan.

The Unviersity has sufficient number of classrooms and seminar halls to accommodate the teaching learning process effectively. All faculty members have been provided with ICT enabled services. The Education Department has Lab for its students.The Computer Centre of the University provides quality service to the university community in computing facilities, training, teaching, website hosting, virtual classes etc. It helps researchers to get their valuable data analyzed, extends Internet facilities in the University, enables access to World Wide Web etc. to the students of various courses. There are also 03 well equipped computer labs, 01 language lab, 01 education technology lab and 06 smart class rooms for practical experience.

There is also a Yajnashala in the University's campus where diploma and training courses for the priests of the capital city, are organized. Various types of Bhadra Mandalas have been made in the Yagyashala for the Vedic rituals and yagyas. In this Yagyashala, study and teaching is done by the Guru-Shishya tradition. The Computer centre provides e-campus facility comprises of Internet, open for 24x7 with a high speed and uninterrupted connectivity. Labs, hostel and libraries provided computing facilities through the wired Gigabit LAN connectivity and Wireless Points.

4.1.2 - The institution has adequate facilities for cultural activities, yoga, games (indoor, outdoor) and sports. (gymnasium, yoga centre, auditorium, etc.)

The University encourages sports and cultural activities in the campus for overall development of students. A number of players has played district, university, level games. It provides indoor games as well as outdoor games. The University also had one Assistant Professor- Physical Education for overall supervision and conduct of sports related activities in the University. The University has adequate facilities of Basketball Court, Badminton Court, Volleyball Court etc. The University also has playground for various sports activities like Football, Cricket, Kushti, Kho-Kho etc.For healthy recreation and mutual contact among the University's female employees, the university provides one recreation room. The Saraswat Sadhna Sadanam of the University also have a Gymnasium facility whereall students have access to the gym at the University.The campus has an indoor fully air-conditioned in-house gymnasium, which is in keeping with the goal of all-round development of the students. It has top-of-the-line fitness and workout equipment, such as treadmills and strength machines.

The University also have well-equipped basement halls for organizing annual functions and cultural events. Major cultural events are organized at the basement Hall of Swarna Jayanti Sadanam.

This university is located on prime land near a number of national and international academic institutions and provides for the faculty and students a serene ambience to learn, teach, acquire skills and develop their personality. The four Academic Buildings in the University are:-Shaikshanik Sadan,Saraswat Sadhana Sadan,Vrihaspati Bhawan,Swarna Jayanti Sadan. The University has an excellent infrastructure and facilities like gymnasium,Rain Water Harvesting System, Roof Top Solar Power Plant, Recreation Room, Sewage Treatment Plant, Guest House etc. The University has a basic Health Care unit to provide medical support to needy students, faculty and staff. Further, the it has empanelled various super specialty hospitals to provide medical facilities to its staff. All the class rooms are well furnished and ventilated.

The University also have residential complex for teaching and non-teaching employees and a Vice-Chancellor Bunglow.The University has one boys' hostel, which has 51 rooms and can accommodate 99 students.The management and maintenance is controlled by the Hostel Warden and the Hostel Committee.The institution has a significant canteen facility on campus that is managed by a third party caterer wherein a variety of Indian cuisine and snack items at significantly subsidised rates of the finest quality are served.The university is designed and constructed to keep the basic needs of differently abled people in mind while providing a friendly atmosphere.

The university facilitates several techniques for the management of degradable and non-degradable waste to reduce, reuse and recycle the waste. The UWD has been entrusted for the work of maintenance and management of various waste management of the University. The university has different dustbins to segregate the different waste like solid, biomedical, etc.Every day the waste is collected in bins and disposed to a place where it can be converted into manure.In 2006-07, the University installed the latest FAB type Sewage Treatment Plant with a filter press with a capacity of 120 kL/d to reuse wastewater generated by the University complex's kitchens, baths, and latrines, as well as other services for flushing toilets in Non-Residential Buildings and for horticultural purposes.Throughout the year, the University uses 100 % of the wastewater by treating it through the STP.The University has also adopted the measures of Rain Water Harvesting in the University campus, through which it is able to make optimum use of the Rain Water in campus. Due to rain water harvesting Quality of ground water has improved and water level in tubewells has also increased.For solid waste management different bins have been placed at different departments. This ensures that solid waste segregated at the source. The university has organized Swach Bharat Mission. Under this mission, the need of recycling the solid and biomedical waste has been elaborated. People from different aspects of life delivered their talks about the proper usage of waste.
