The implementation of ABC is envisioned to revolutionize the educational landscape by enabling the University to maintain a comprehensive digital repository of credits earned by students.

Under the ABC system, students accrue credits for a specific program, and these credits can be seamlessly transferred or redeemed at other institutions with the student's consent. This mechanism is pivotal for facilitating successful study mobility, allowing students to leverage their earned credits across different academic environments.

To ensure the smooth execution of ABC, SLBSNSU has constituted a dedicated Committee within the Academic Council. This committee is tasked with overseeing the implementation of ABC through the National Academic Depository (NAD), which serves as the backbone for the secure storage and retrieval of academic data.

The Academic Bank of Credits at SLBSNSU is conceptualized to operate in a manner akin to the National Academic Depository (NAD). It will function as a digital storehouse of academic awards and a repository of students' academic data. However, the final processes related to credit redemption, issuance of certificates, and the compilation of award records will be administered by the University through the NAD Platform.

In essence, the establishment of the Academic Bank of Credits at SLBSNSU aligns with the NEP 2020 vision of fostering greater flexibility and mobility in education. This forward-looking approach not only streamlines credit transfer processes but also ensures the secure and transparent management of academic records through the integration of the NAD Platform. Shri Lal Bahadur Shastri National Sanskrit University (SLBSNSU) is dedicated to providing exceptional facilities for teaching, learning, and research in Sanskrit. The university, with around 103faculty members and approximately 2037students from diverse regions of India, maintains a balanced male-female ratio. The four Academic Buildings-Shaikshanik Sadan, Saraswat Sadhana Sadan, Brihaspati Bhawan, and Swarna Jayanti Sadan-are equipped with ample classrooms and seminar halls, ensuring an effective teachinglearning process.

Faculty members benefit from ICT-enabled services, enhancing their teaching capabilities. The Education Department has a dedicated laboratory for practical learning experiences. The Computer Centre plays a pivotal role, providing quality computing services, supporting training, teaching, website hosting, and virtual classes. Well-equipped computer labs, a language lab, an education technology lab, and six smart classrooms contribute to practical experiences.

SLBSNSU embraces traditional practices with the Yajnashala on campus, hosting diploma and training courses for priests. The Computer Centre ensures 24x7 access to high-speed Internet, supporting the e-campus facility. Wired Gigabit LAN connectivity and wireless points extend computing facilities to labs, hostels, and libraries. This robust infrastructure underscores SLBSNSU's commitment to providing a rich, technologically supported learning environment, fostering excellence in Sanskrit education.

The university boasts four Academic Buildings-Shaikshanik Sadan, Saraswat Sadhana Sadan, Vrihaspati Bhawan, and Swarna Jayanti Sadan-comprising well-furnished and ventilated classrooms. The infrastructure includes essential facilities such as a gymnasium, Rain Water Harvesting System, Roof Top Solar Power Plant, Recreation Room, Sewage Treatment Plant, Guest House, and a basic Health Care unit to cater to the medical needs of students, faculty, and staff.

Residential complexes for teaching and non-teaching employees, along with a Vice-Chancellor's Bungalow, contribute to the holistic living experience on campus. The boys' hostel, equipped with 51 rooms accommodating 99 students, is managed by the Hostel Warden and Committee. A well-maintained canteen, operated by a third-party caterer, offers a variety of Indian cuisine and snack items at subsidized rates.

Importantly, SLBSNSU prioritizes inclusivity by designing the campus to be friendly and accessible for differently-abled individuals, ensuring a supportive and welcoming atmosphere for everyone. Overall, the university's commitment to providing a wellequipped and nurturing environment underscores its dedication to the welfare and satisfaction of its academic community.

4.2 - Library as a Learning Resource

• The library of Shri Lal Bahadur Shastri National Sanskrit University (SLBSNSU) has embraced a comprehensive approach to library management through the implementation of an Integrated Library Management System (ILMS). The software utilized is LIBSYS 10 (Web Centric), which was upgraded from LIBSYS version-7 in February 2022.

The library's automation journey began in 2011 with the procurement and installation of LIBSYS version-7. This ILMS included fully functional modules such as Acquisition, Cataloguing, Circulation, Serials Control, and Online Public Access Catalog (OPAC). The system operated in a serverclient mode, with a central server maintaining the centralized data located in the university's Computer Centre. Five terminals/machines connected to the server were strategically placed in the library to facilitate seamless automation activities.

In a significant advancement, SLBSNSU introduced Radio Frequency Identification Device (RFID) technology in 2021 to enhance automation. The RFID technology involves tagging almost all books with radio frequency devices, streamlining the library's processes.

This fully automated library system, operating on LIBSYS 10 (Web Centric), underscores SLBSNSU's commitment to leveraging technology for efficient library management. The integration of ILMS and RFID technology contributes to a modern and digitized library environment, enhancing accessibility and user experience for the academic community.

SLBSNSU's IT infrastructure reflects its commitment to modern technology and efficient services. Key features include three wellequipped air-conditioned labs with internet access and interactive tools, a Language Lab, Educational Technology Lab, and a dedicated Computer Lab for the Education Department. The University boasts high-speed internet connectivity of 1.0 GBPS under the National Knowledge Network (NKN) Project of the Ministry of Education.

A Virtual e-Class Room facilitates the recording of video lectures in various Sanskrit disciplines for MOOCs and the SWAYAM portal of UGC. The University's trilingual website in Sanskrit, Hindi, and English versions is diligently maintained. An EPABX facility with 550 extension lines ensures effective communication, while an Online Feedback System enables stakeholders to provide valuable feedback.

In line with evolving technologies, the Computer Centre regularly upgrades its equipment, including servers, software, and networking components, ensuring that SLBSNSU remains at the forefront of IT integration for enhanced academic and administrative efficiency.

Optimizing fund utilization, SLBSNSU employs measures such as organizing academic activities, judicious control over administrative expenses, and shared facilities among departments. Faculty members are encouraged to secure external project funding from government agencies for on-campus research.

Shri Lal Bahadur Shastri National Sanskrit University (SLBSNSU) is dedicated to providing exceptional facilities for teaching, learning, and research in Sanskrit. The university, with around 103faculty members and approximately 2037students from diverse regions of India, maintains a balanced male-female ratio. The four Academic Buildings-Shaikshanik Sadan, Saraswat Sadhana Sadan, Brihaspati Bhawan, and Swarna Jayanti Sadan-are equipped with ample classrooms and seminar halls, ensuring an effective teaching-learning process.

Faculty members benefit from ICT-enabled services, enhancing their teaching capabilities. The Education Department has a dedicated laboratory for practical learning experiences. The Computer Centre plays a pivotal role, providing quality computing services, supporting training, teaching, website hosting, and virtual classes. Well-equipped computer labs, a language lab, an education technology lab, and six smart classrooms contribute to practical experiences.

SLBSNSU embraces traditional practices with the Yajnashala on campus, hosting diploma and training courses for priests. The Computer Centre ensures 24x7 access to high-speed Internet, supporting the e-campus facility. Wired Gigabit LAN connectivity and wireless points extend computing facilities to labs, hostels, and libraries. This robust infrastructure underscores SLBSNSU's commitment to providing a rich, technologically supported learning environment, fostering excellence in Sanskrit education.

The university boasts four Academic Buildings-Shaikshanik Sadan, Saraswat Sadhana Sadan, Vrihaspati Bhawan, and Swarna Jayanti Sadan-comprising well-furnished and ventilated classrooms. The infrastructure includes essential facilities such as a gymnasium, Rain Water Harvesting System, Roof Top Solar Power Plant, Recreation Room, Sewage Treatment Plant, Guest House, and a basic Health Care unit to cater to the medical needs of students, faculty, and staff.

Residential complexes for teaching and non-teaching employees, along with a Vice-Chancellor's Bungalow, contribute to the holistic living experience on campus. The boys' hostel, equipped with 51 rooms accommodating 99 students, is managed by the Hostel Warden and Committee. A well-maintained canteen, operated by a third-party caterer, offers a variety of Indian cuisine and snack items at subsidized rates.

Importantly, SLBSNSU prioritizes inclusivity by designing the campus to be friendly and accessible for differently-abled individuals, ensuring a supportive and welcoming atmosphere for everyone. Overall, the university's commitment to providing a well-equipped and nurturing environment underscores its dedication to the welfare and satisfaction of its academic community.

4.2 - Library as a Learning Resource

4.2.1 - Library is automated using Integrated Library Management System (ILMS) and has digitisation facility

• The library of Shri Lal Bahadur Shastri National Sanskrit University (SLBSNSU) has embraced a comprehensive approach to library management through the implementation of an Integrated Library Management System (ILMS). The software utilized is LIBSYS 10 (Web Centric), which was upgraded from LIBSYS version-7 in February 2022.

The library's automation journey began in 2011 with the procurement and installation of LIBSYS version-7. This ILMS included fully functional modules such as Acquisition, Cataloguing, Circulation, Serials Control, and Online Public Access Catalog (OPAC). The system operated in a server-client mode, with a central server maintaining the centralized data located in the university's Computer Centre. Five terminals/machines connected to the server were strategically placed in the library to facilitate seamless automation activities.

In a significant advancement, SLBSNSU introduced Radio Frequency Identification Device (RFID) technology in 2021 to enhance automation. The RFID technology involves tagging almost all books with radio frequency devices, streamlining the library's processes.

This fully automated library system, operating on LIBSYS 10 (Web Centric), underscores SLBSNSU's commitment to leveraging technology for efficient library management. The integration of ILMS and RFID technology contributes to a modern and digitized library environment, enhancing accessibility and user experience for the academic community.

Key features include three well-equipped air-conditioned labs with internet access and interactive tools, a Language Lab, Educational Technology Lab, and a dedicated Computer Lab for the Education Department. The University boasts high-speed internet connectivity of 1.0 GBPS under the National Knowledge Network (NKN) Project of the Ministry of Education. A Virtual e-Class Room facilitates the recording of video lectures in various Sanskrit disciplines for MOOCs and the SWAYAM portal of UGC. The University's trilingual website in Sanskrit, Hindi, and English versions is diligently maintained. An EPABX facility with 550 extension lines ensures effective communication, while an Online Feedback System enables stakeholders to provide valuable feedback.

In line with evolving technologies, the Computer Centre regularly upgrades its equipment, including servers, software, and networking components, ensuring that SLBSNSU remains at the forefront of IT integration for enhanced academic and administrative efficiency.

Optimizing fund utilization, SLBSNSU employs measures such as organizing academic activities, judicious control over administrative expenses, and shared facilities among departments. Faculty members are encouraged to secure external project funding from government agencies for on-campus research.
